FREEDOM OF INFORMATION REQUEST – FOI 1026/24 BURGLARY / THEFTS OF PRAMS

I refer to your request for information received by Cumbria Constabulary on 15th November 2024. I note you seek access to the following information:

I would like to request the following information under the Freedom of Information Act, as below:

- *Please supply, broken down by either calendar or financial year - whichever is more readily accessible - the number of thefts and burglaries reported in your service area in which a pram, buggy, pushchair or stroller is mentioned as an item that was taken between January 2021 and the most recent possible date.*
 - *Please break these down by theft and burglary where possible.*
 - *Please break these down by calendar/financial year.*

Your request for information has now been considered and I can confirm Cumbria Constabulary does hold information relevant to your request and I have today decided to disclose this to you.

In order to locate and retrieve information relevant to your request keyword searches have been undertaken of records held on the Constabulary's Crime Recording system. The keywords used to undertake this search were:

'pram', 'buggy', 'pushchair' and 'stroller'.

The results of the search were manually reviewed to confirm relevance to your request.
