FREEDOM OF INFORMATION REQUEST – FOI 255/25 Traffic Cameras

I refer to your request for information received by Cumbria Constabulary on the 26th of February 2025. I note you seek access to the following information:

- 1. I would like to know the reason(s) why the locations of traffic cameras are released in advance to the public.*
- 2. In the last year 2024 How much £ was collected in fines during these exercises with traffic cameras*
- 3. How much in total was collected in total for speeding fines in Cumbria. Please give monetary values.*
- 4. What was the prosecution rate for the traffic camera exercises - numbers of prosecutions and also the prosecution rate for the whole of Cumbria in the same year.*

In addition to the above I also refer to your clarification email received on the 26th of February with the following:

2 -How much in monetary terms was collected in 2024 during the placing of the traffic camera vans.

I am referring to the Road Safety Camera vans - the locations of which are publicised.

*4 - How many drivers were caught speeding in 2024 by the Road Safety Camera vans.
How many drivers were caught speeding in 2024 in Cumbria in total.*

Your request for information has now been considered and I can confirm Cumbria Constabulary does hold some information relevant to your request and where this is the case I have today decided to disclose this to you.

The information in response to your request has been provided by the Constabulary's Central Ticket office and Safety Camera Team.

It is a transparent response to the public to ensure that we engage and demonstrate our deployments to reduce KSI collisions and assist our aim of achieving vision zero.

9011 members of the public paid the £100 and accepted the fixed penalty for speeding fines from all cameras in Cumbria.

Question 4 –

20514 members of the public were sent notices in relation to speeding detected by Camera vans.

33751 members of the public were sent notices in relation to speeding from all cameras in Cumbria.
