FREEDOM OF INFORMATION REQUEST – FOI 331/25

I refer to your request for information received by Cumbria Constabulary on 17 March 2025. I note you seek access to the following information:

This is an information request relating to suspects charged where a vehicle involved was registered with the Motability scheme

Please provide the following information, for the 2019/20, 2020/21, 2021/22, 2022/23, 2023/24 and 2024/25 (to present) financial years:

- The number of suspects charged in each year where a vehicle involved in the alleged crime was registered with the motability scheme*
- A breakdown by crime*

Your request for information has now been considered and I can confirm the information you seek is held by Cumbria Constabulary. However, for this information to be extracted it would require a manual review of every crime in order to ascertain whether a vehicle was registered with the motability scheme. This information would also be dependent on the owner advising us that the vehicle does fall within the motability scheme and therefore any information held may not be a true and accurate number.

I have estimated the time required to extract the relevant information required will exceed the “appropriate limit” as this would require a manual review of all relevant entries.

The “appropriate limit” is set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 and the current limit for police forces is set at £450, which equates to 18 hours of work.

Section 12(1) of the Freedom of Information Act does not oblige a public authority to comply with a request for information, if the authority estimates that the cost of complying with the request will exceed the appropriate limit. In view of this, and in accordance with Section 17(5) of the Act, this letter serves as a Refusal Notice for your request.

In accordance with my duty under Section 16 of the Freedom of Information Act, 2000 (Duty to provide advice and assistance), I have tried to think of a way to recommend that your request may be refined to bring it under the limit explained above. At this time, unfortunately, I have no suggestions, due to the way that the information requested is recorded.

If you remain dissatisfied following conclusion of the internal review, you have the right, under section 50 of the Freedom of Information Act, to complain directly to the Information Commissioner.
