FREEDOM OF INFORMATION REQUEST – FOI 1091/24 Arrests by Nationality and type of offence 01.07.23-30.06.24

I refer to your request for information received by Cumbria Constabulary on 3rd of December 2024. I note you seek access to the following information:

I would like to request data on the number of arrests made in your PFA, by nationality and – if possible – type of offence.

- 1. Please provide the number of arrests for the following nationality groups: UK/Ireland; EEA; Non-EEA.*
- 2. In addition to providing a figure for all types of offence, please provide figures for the following categories, if possible: violence; theft; robbery; drugs; sexual offences; fraud; other.*

Please provide this information for 1st July 2023 to 30th June 2024.

Your request for information has now been considered and I can confirm Cumbria Constabulary does hold some information relevant to your request and where this is the case I have today decided to disclose this to you.
