FREEDOM OF INFORMATION REQUEST – FOI 1131/24 ‘Everyone’s invited’ website

I refer to your request for information received by Cumbria Constabulary on the 19th of December 2024. I note you seek access to the following information:

As of 19 December 2024:

(2) Out of that total number of allegations in (1), how many:

- (a) resulted in a police investigation;
- (b) resulted in a suspect being charged with an offence(s); and
- (c) of the total number of suspects charged in (b):
 - i. how many suspects have been acquitted; and
 - ii. how many suspects have been convicted?

Your request for information has now been considered and I can confirm that Cumbria Constabulary do not hold any information relevant to your request.

Cumbria Constabulary do not have a specific flag or other type of categorisation to connect offences to the website ‘Everyone’s invited’. A search of the Constabulary’s crime recording system has been conducted for the period requested 01/06/2020-19/12/24 using a key word search which has resulted in a nil return.

It should also be noted submissions on the website *Everyone’s Invited* are anonymised, so it is not possible to manually link crimes recorded in our data with the website’s submissions. Whilst every care has been taken in the retrieval of the information provided, please do not hesitate to contact us for clarification, if you do have any issues or queries relating to this data.
