FREEDOM OF INFORMATION REQUEST – FOI 573/25 Roblox Offences

I refer to your request for information which was received by Cumbria Constabulary on 27th May 2025. I note you seek access to the following information:

For 2024 and 2023:

1. *How many instances of offences were reported to the police forced regarding the game “Roblox”.*
 - a. *A breakdown of the type of offence i.e. “Sexual Activity Involving A Child Under 13”, “Sexual Activity Involving A Child Under 16”, “Sexual grooming”, “Engage in sexual communication with a child”. Etc.*

Your request for information has now been considered and I can confirm Cumbria Constabulary does hold some information relevant to your request and where this is the case I have today decided to disclose this to you.

The information provided in response to your request has been extracted from the Constabulary's crime recording system. A keyword search was conducted using the term Roblox.

Please note: A keyword search may not accurately identify all information held by the Constabulary. If, for example, the words were recorded in a different field, or if another name or term was used to describe the site, any such records would not be identified by the keyword search which has been undertaken.
