FREEDOM OF INFORMATION REQUEST – FOI 1324/25 Residential Burglaries

I refer to your request for information which was received by Cumbria Constabulary on 19th September 2025. I note you seek access to the following information:

1. Please could you state the number of residential burglaries that you have recorded as having taken place on 25.12.24?

2. In relation to all of those offences recorded by you in Q.1 could you provide me with a table showing the Home Office prescribed Outcomes for all of those offences? Eg. Charged, Cautioned, Ongoing, Transferred to Other Force, Evidential Problems etc.

Your request for information has now been considered and I can confirm Cumbria Constabulary does hold some information relevant to your request and where this is the case I have today decided to disclose this to you.

Please note: the data provided is correct as of the date the response is sent, there is a chance that the crime may receive a charge/different outcome in future, so the data may change.

The number of residential burglaries that have taken place on 25/12/2024.

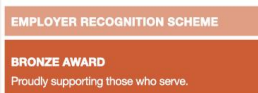
