FREEDOM OF INFORMATION REQUEST – FOI 1368/25 Islamophobia Reports

I refer to your request for information which was received by Cumbria Constabulary on 6th October 2025. I note you seek access to the following information:

1. How many reports of Islamophobia were made to you each week so far in 2025?

Your request for information has now been considered and I can confirm Cumbria Constabulary does hold some information relevant to your request and where this is the case I have today decided to disclose this to you.

A keyword search of racial offences has been conducted on the Cumbria Constabulary system using the term 'Muslim'. As the request asks for reports, the data below shows the number of recorded crimes and recorded non-crime hate incidents. Only weeks that have data are shown in the table.

Please note: A keyword search may not accurately identify all information held by the Constabulary. If, for example, the words were recorded in a different field, or if another name or term was used, any such records would not be identified by the keyword search which has been undertaken.
